

**BRP BY ADVENTURE Game**  
**COMPLETE REGULATIONS**

- OPERATION N°51484 -  
FROM OCTOBER 11, 2024 TO OCTOBER 27, 2024

**Article 1: Organizing company**

BRP France, a company with share capital of €100,000, headquartered at Route de la Côte d'Azur, 13 590 MEYREUIL, France, registered under RCS Aix-en-Provence B 482 596 533 (hereinafter referred to as the "Organizing Company") is organizing a no-obligation Game from 11/10/2024 to 27/10/2024 [23:59] (daytime included).

**Article 2: Participants and eligibility**

This no-obligation contest is open exclusively to adults residing in metropolitan France (including Corsica and Monaco), Germany or Austria, the Netherlands, Belgium, Luxembourg, Italy, Spain and the United Kingdom.

Persons who do not meet the above conditions are excluded from the Game, as are members of the Organizing Body's staff and any person directly or indirectly involved in the design, production or management of the Game, as well as their spouses and family members: direct ascendants and descendants or other relatives, whether or not living under their roof.

The Game is limited to one entry and one prize per person (same surname, same first name, same postal address, same e-mail address) or per company name (same name/company name, same address, same e-mail address) for the entire duration of the Game.

The Organizing Body reserves the right to ask any participant to provide proof of the above conditions. Any person failing to meet these conditions or refusing to provide proof will be excluded from the Game and, in the event of winning, will not be entitled to his or her prize.

Participation in the Game implies full acceptance of these rules.

**Article 3: Terms of participation**

**STEP 1:** Visit your nearest dealership between 11/10/2024 and 27/10/2024 and **scan** the QR code present in the dealership.

**STEP 2: REGISTER online no later than 27/10/2024 [23:59].**

- Enter your personal details (surname, first name, postal address, email address, telephone number)
- Select your point of sale
- VALIDATE your entry and **find out** immediately if you win a prize.

***The winnings are to be picked up immediately at the dealership.***

**After your participation, you will be automatically entered into the draw that will take place on 01/11/2024 for a chance to win one of the 3 BRP machines.**

Any participation made contrary to the provisions of the present rules will render the participation invalid. Any participant suspected of fraud may be excluded from the Contest by "La Société Organisatrice" without having to justify this. Any identification or participation that is incomplete, erroneous or illegible, whether intentionally or not, or made in a form other than that provided for in these rules, will be considered null and void.

**Article 4: Designation of winners and prizes up for grabs**

#### **4.1 : By instant win**

The following prizes are on offer:

**The winnings are to be picked up immediately at the dealership.**

Winners will be designated by a system of open instant-win prizes randomly distributed throughout the duration of the Operation. Each instant-win period corresponds to a single prize.

If the entry corresponds to one of the instant winners, the participant wins the gift at stake at that instant winner. The instant winners are programmed before the start of the Game and spread over the Game period.

Instant win prizes are said to be "open", which means that if no participant plays during one of the instant win prizes, the corresponding prize will be awarded to the first participant after this instant win.

The list of 1,472 (one thousand, four hundred and seventy-two) instant winners randomly determined by computer before the start of the Contest is filed with SELARL AIX JUR ISTRES by SAS AIX JUR ISTRES 365 route de Milles, résidence du Soleil 13090 Aix en Provence. The time taken into account will be that of the clock on the computer hosting the Game.

#### **4.2 : By drawing lots**

The following are involved:

- **3 (three) BRP Renegade 110 XXC machines, with a maximum unit value of €5,400 - £5,600 incl. VAT.**

Registration and start-up costs are included in the prize. However, the rest of the vehicle's operating costs (fuel, insurance, maintenance, etc.) are the responsibility of the winner. Should the winner fail to reply within 15 days of the date of dispatch of the e-mail informing him/her of his/her prize, the winner will be deemed to have renounced his/her prize. A new draw will be carried out under the supervision of a court commissioner, and the prize will be reallocated to a new winner.

#### **Article 6: Use of participants' personal data**

The personal data collected within the framework of the operation is subject to computer processing by BRP, the data controller, in order to manage the reimbursement of its commercial offers on its products and services (on the basis of the execution of a contract). The Organizing Body reserves the right to extend, shorten, modify or cancel the Game at any time, in particular in the event of force majeure, without participants being entitled to claim any compensation. The rules, modified by amendment(s), will be filed, if necessary, with SAS AIX JUR-ISTRES.

#### **Article 8: Industrial and intellectual property**

The reproduction, representation or use of all or part of the elements making up the Game, including these rules, is strictly prohibited.
